1.	2/8/10	PTW	States he has no claim 2/18/10.
2..	2/16/10	PTW Employee of Settling Defendant	States she does not want to be part of the case.
3	2/12/10	PTW(?)	Physician. Gives no reason and refuses further contact.
4.	Undated; postmark 2/20/10	ATW	States expressly in letter that he will not sue Hollywood industry in that "they did not directly hurt me."
5.	2/18/10	Not a class member	In letter of 3/23/10, he states "I have NEVER (his emphasis) written any scripts for TV and have NO interest in doing so. I feel that I do not have the right to be included in your litigation because it would be taking money under false pretenses."
6.	2/25/10	Not a class member	States in email 4/4/10: "I have no discrimination claim against the litigants as none of my work was ever submitted for television."
7.	2/12/10	PTW	Handwritten reply 3/24/10 stating that she feels she has no claim and doesn't want to be party to any litigation.
8.	2/28/10	Former ATW but no continuing interest in tv writing	By email 4/20/10, she writes "I'm simply opting out of the TV Writers Age Discrimination Settlement and I do not plan on bringing an action against the industry."
9.	3/17/10	ATW?; denies she's a member of the class	Letter of 3/17/10 confirms her belief that she's not a member of any class. She states that "I have not been discriminated against by the TV industry because of my age since I had my 40 th birthday."
10.	3/24/10	ATW	He is 41 years old and has worked predominantly in production and visual effects. In email dated 4/10, states he has no claim and cannot in good conscience accept money he is not entitled to.
11.	3/22/10	ATW (?) Accomplished writer and PhD Psychologist	No reason stated in letter.

12.	3/30/10	Not a class member	No reason stated in letter but confirms she didn't perform TV work for compensation; email of 4/6 states that she just turned 40 in December 09, never wrote for television, has no claim and doesn't consider herself a member of the class.
13.	3/31/10	ATW	Wrote by hand and has no phone or email. She responded 4/10/10 with handwritten letter stating she opted out "because I am not interested in writing for television right now."
14.	4/8/10	ATW	Originally stated he had no age discrimination claim; later stated he refuses to release any claims.
15.	4/6/10	PTW	No response.
16.	3/15/10	ATW	Hand-written note received only by Garden City: "I am not interested in my name or myself being involved in this. I have not experienced age discrimination." Further stated in writing "I have no interest in filing a claim in this case and I opt out."
17.	4/7/10	ATW	Stated she is not a member of the class as she did not write for television during the period in question.
18.	4/7/10	ATW	Didn't realize the release was limited to age discrimination in Television Writing Opportunities. JL suggested he could file a claim but he said it "wasn't a big deal" because he "wouldn't get anything any way" as he is an ATW who does production work.
19.	4/8/10	PTW	States she couldn't prove age discrimination during class period as she got first job after 40.
20.	4/4/10	ATW	No response.
21.	4/8/10	ATW	Fiction writer. Not interested in filing a claim.
22.	4/7/10	ATW(?)	No response
